Subject: <u>Appeal for Intervention to Facilitate Proportionate Registries in Line with Amitabh Kant Committee Guidelines</u>

Respected Sir,

We, the homebuyers of [Mahagun Mezzaria / Nexgen Infracon], seek your kind intervention to resolve a long-pending matter that has caused us severe hardship despite our full compliance with financial obligations.

## 1. Background of Compliance and Reliefs Granted

- After depositing the first 25% of dues, certain registries were permitted on a proportionate basis.
- Subsequently, Nexgen Infracon has received substantial relief from the Hon'ble
   NGT, amounting to nearly 56% of total dues.
- As a result, approximately 81% of the dues now stand reduced. However, no formal notification has been issued, nor have proportionate registries commenced in line with the revised position.

### 2. Current Status

- Documentation is now complete.
- Only two correctable deficiencies remain in the Structural Audit, which are in the process of being addressed.
- Despite this, our applications are repeatedly being redirected between the Group Housing and Planning departments, without any conclusive outcome.

## 3. Our Humble Request

- In line with the Amitabh Kant Committee Guidelines, we request that a conditional NOC be granted immediately.
- Proportionate registries may kindly be initiated, ensuring that genuine homebuyers—who have already paid 100% of their dues years ago—are not deprived of their legal rights to their homes.

### 4. Clarification of Intent

- We are not seeking any waiver of dues legitimately payable to the Authority.
- Our only plea is for timely facilitation of registries, so that innocent homebuyers are not made to suffer for circumstances beyond their control.

**Conclusion** Sir, we have been waiting for years, bearing both financial and emotional strain, while continuing to comply with every requirement placed upon us. We now look to your leadership and intervention to break this cycle of delay and grant us the long-awaited relief that is rightfully due.

We remain hopeful that under your guidance, justice will be delivered, and the faith of thousands of homebuyers in the Authority's fairness will be reaffirmed.
