Dear Mr. Upadhyay,

You have received our reminder dated 21 August 2025 requesting confirmation of your agreed meeting with residents on 25 August 2025 at 11:30 AM. To date, we have not received any response from you. This failure to acknowledge and honor commitments is unacceptable and falls far below the standard of professionalism and accountability we expect from Mahagun Mezzaria's Facility Management team.

Accordingly, we hereby demand:

1. Your personal presence, along with your full facility management team, at the residents' meeting on **25 August 2025 at 11:30 AM sharp** in your office.
2. The **immediate removal** of the notice posted on MyGate on 20 August 2025 stating that you will not interact with residents. That notice is not only a breach of your core responsibilities but reeks of contempt for resident safety and undermines transparent communication.

At our last meeting on 4 August 2025, you undertook to provide a detailed update on fire-safety equipment progress, compliance certificates, sensor installations, and obstruction-clearance work. We expect all promised documentation, status reports, and corrective-action plans to be on your desk at 11:30 AM on 25 August. No further excuses or delays will be tolerated.

Let this communication set the tone for accountability and respect. Should you fail to attend or if the MyGate notice remains in place, we will escalate this breach to the Noida Authority, the relevant fire-safety regulator, and pursue all available legal and regulatory remedies without further notice.

We trust you will treat this matter with the urgency and seriousness it demands.
