Subject: Escalation Notice – Continued Facility Lapses in Fire Safety Compliance

Dear Mr. Upadhyay,

This communication is being issued on behalf of the *Quest for Safety Team* in response to persistent inaction and disregard from the Facility and Management teams at Mahagun Mezzaria regarding fire safety protocols and information.

Since the third week of July, we have made multiple efforts to engage with your team to understand the status of fire safety installations across the premises. Despite confirming a scheduled meeting with Mr. AmritLal Yadav, you were notably absent. During that meeting, it became alarmingly evident that the Facility team is *uninformed* and *unprepared* to answer even basic fire safety questions critical to the welfare of residents.

To help guide progress, a preliminary list of essential queries was provided to Mr. Yadav and we were assured that this information would be furnished in our next meeting with you. Following that, on **20th July**, we submitted a detailed and organized request for this data. **No acknowledgement or response** was received. A follow-up was sent on **22nd July**, also without reply.

On **29th July**, after waiting over an hour, we met with you in person and handed over printed copies of our questions and reminders. You assured us that you would coordinate a joint meeting with Mr. A Nirula. **It has now been two full days**, and once again—*no action, no communication*.

This pattern of **indifference** is unacceptable and deeply concerning. It reflects a troubling lack of commitment to resident safety and an organizational culture that appears to minimize life-critical issues. We must stress: this is not a routine operational matter—it is about **life and safety**.

The Quest for Safety Team remains open to assisting with resident coordination and constructive dialogue. However, **responsibility for the safety infrastructure, its documentation, maintenance, and transparency lies with you and the Management of Mahagun Mezzaria.**

The current negligence demands immediate redress, and we call on the top management to break their silence and take corrective measures—without further delay.
