Subject: Continued Default by M/s Nexgen (Mahagun Group) on Dues of ₹12 Crore—Request for Intervention to Facilitate OC, CC & Registries for Mahagun Mezzaria

Dear Sir,

This is to respectfully remind and seek urgent action regarding our meeting with you at your office on 2nd July 2025 concerning M/s Nexgen Infracon (Mahagun Group) and their prolonged non-payment of ₹12 crore dues to Noida Authority, critical for the issuance of Occupancy Certificates (OC) and Completion Certificates (CC) for "Mahagun Mezzaria," GH-01/A, Sec-78, Noida

During that meeting, Mr. Amit Jain, Managing Director of Mahagun, had assured you—and us—that these dues would be cleared latest by July 20, thereby enabling the grant of OC for Towers T2 and T3, CC for the entire society, and initiating registry for the 317 remaining flats.

Regretfully, despite numerous assurances and at least six prior defaults in the past year, Mr. Jain has again failed to honor his commitment. This repetitive pattern raises serious concern about the builder's intent and undermines the legitimate rights of hundreds of homebuyers.

It is important to note that:

- The project was scheduled for completion before 2017.
- Homebuyers have paid 100% dues to the builder years ago.
- Due to delays in obtaining OC/CC—resulting from builder's failure to clear statutory dues—registries remain stalled for the majority of flat owners.

 Buyers continue to bear the burden and uncertainty despite having fulfilled all financial obligations.

Sir, as the Chief of Noida Authority and a key public office bearer entrusted with safeguarding citizen welfare, we earnestly request your intervention to provide relief to innocent homeowners. Timely action on this matter can prevent further hardship and restore hope among those who continue to suffer through no fault of their own.
