1. NAME OF THE SOCIETY:

The name of the Society (herein after referred to as the 'Society') shall be MEZZARIA FLAT BUYERS WELFARE ASSOCIATION

REGISTERED OFFICE:

The registered office of Society shall remain in the National Capital Territory of Delhi and Situated at H. No. C9, G/F, NDSE, Part-I, New Delhi- 110049.

2. AREA OF OPERATION:

The area of operation of the Society shall cover Delhi & NCR.

3. AIMS AND OBJECTIVES:

The aims and objects for which the Society is established are as under:

- 1. To protect the collective interest of the registered members of the Association;
- 2. To protect the interest of the members by representing the Association at various relevant forums, appropriate government, quasi government, judicial, statutory and other relevant bodies, including local municipal bodies, authorities, builders, developers, association of builders & developers and other organizations which may impact the members monetarily or otherwise and take all such steps as may be necessary in this regard;
- 3. To perform such other legal and lawful acts that may be necessary for the members of the Association;
- 4. To work for the wellbeing and safety of the members of the Association, who are owners of residential/commercial plot(s) anywhere in India;
- 5. To project, protect and pursue all matters in the collective interests of members with the Society or needy persons including timely delivery and possession of plots;
- 6. To coordinate among members to work towards greater unity amongst members and strive to solve present and future problems of the members;
- 7. To organize charitable services for needy people;

- 8. To receive and accept donations and contributions in cash or kind from any person(s)/society, trust/ firms/ institute or company from all over world for the furtherance of the aims and objects of the society and upon such terms and conditions to be determined from time to time;
- 9. To sell, let, lease, mortgage, gift, dispose off, develop, bind or alter or improve or turn into account all or any of the property or assets of society as maybe though expedient with a view to the promotion of its objects;
- 10. to buy, purchase, construct, take on lease or in exchange, hire or acquire any movable or immovable property or any tenure or description and any estate or interest thereon any rights and privileges which the society may think necessary or convenient for the work of the Society;
- 11. To borrow or raise money from the banks, Financial institution and others from time to time at a reasonable rate with or without security for the purpose of carrying on the aims and objects of the Society on such terms and by giving such security as maybe determined from time to time by the society;
- To invest monies of the society which cannot be applied immediately or at any early date for carrying in the aims and objects;
- 13. To do all acts, matters and things as are incidental or conducive to the attainment of the above aims and objects, or any one or more of them;
- 14. All fund, income, earnings, movable, immovable, properties of the society shall be solely utilized and applies towards the promotion of its aims and objects only as set forth in the Memorandum of Association of the Society and no portion there shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever, to the present or past members of the Society or to any person claiming through one or more of the present or past members. No members of the Society shall have any personal claim or any movable or immovable properties of the Society or make any profits, whatsoever by virtue at his/ her membership.
- 15. To raise funds through donations and grants from public and government and to spend all income to achieve the aims and objectives of the society;
- 16. To perform all such acts as may be necessary for the achievement and accomplishment of the above mentioned aims and objects and all allied social activities and services including to provide financial assistance or to provide donation to the other Trust, Societies and institution having similar objectives.

"RULES & REGULATIONS"

1. NAME OF THE SOCIETY:

Name of the Society shall be: Mezzaria Flat Buyers Welfare Association

2. <u>DEFINITION:</u>

In these Memorandum of Society, unless the context requires otherwise the words shall mean as defined hereunder:

- a. ACT: means the Societies Registration Act, 1860
- b. **ASSOCIATION:** means the group of the Flat owners got together to register this society.
- c. **APARTMENTS:** means Apartment / Building located at Mahagun Mezzaria, Plot No GH-02, Sector 78, Noida- 201301, Uttar Pradesh, India, built and sold by Nexgen Infracon Private Limited (a group Company of Mahagun).
- d. GOVERNING BODY: means the body as nominated as the Governing body at the time of registration of the society and who are elected as member of the Governing body by the members of the Society from time to time.
- e. **RESIDENT:** means any person owing any flat in the Mezzaria Apartment.
- f. MEMBERS: means any person who owns any flat in Mezzaria Apartment either as first owner or second owner/ co owner and his/ her name is entered as Members in the register of the Members of the Society.

g. **DEFAULTING MEMBER**: means any Owner who has not paid the dues to the Association as a result of which the Management Committee declare such member as defaulting member due to his any act which is detrimental to the interest of the Society or its members.

- h. **DEEMED MEMBER:** means a deemed member of the Association; the spouse, parent or any one of the children above 18 years of age who is authorized by such owner and **who is also** a Resident may be treated as a deemed member of the Association in place of such owner.
 - *If the Flat owner is a Company/ body corporate owing the flat for residential purposes, the Company/ body corporate may nominate a deemed member.
- i. **REGISTRAR:** means the Registrar of Societies, appointed under the Act, of National Capital Territory of Delhi.

j. MEMBER/ MEMBERSHIP:

- i. Any person, or persons, HUF, Firm, Association of Persons and /or Company who/which has purchased any flat in the Apartment named Mezzaria and built by M/s Nexgen Infracon Private Limited (hereafter referred to as the "Developer"), at Sector 78, Noida, Uttar Pradesh, India, shall be eligible to become the Member of the Association on deposit of the membership fee and upon entry of his/ her/ their name in the register of members of the Society.
- ii. Any legal heirs, representative, assignee of the person deceased or insolvent person shall also be treated as members.
- iii. The Governing body shall reserve the right to refuse the membership of the Society after communicating the reason for such refusal.

3. ADMISSION FEE & SUBSCRIPTION OF THE MEMBERSHIP:

Admission fee and Subscription shall be as under unless otherwise revised by the Governing Body of the Society.

(a) Admission Fee Rs. 1000/- (b) Subscription Rs. 1000/- per year:

4. TYPES OF MEMBERS:

At present there is only one type of members namely:- General Members who are flat owners in Mezzaria Apartment.

5. TERMINATION OR CESSATION OF MEMBERSHIP:

Governing Body of Society shall have powers to expel/terminate a member or/and Members, from the membership of the above Society, on the following grounds:

- (a) Upon cessation of the ownership of the flat in the Mezzaria Apartment
- (b) on death,
- (c) on written resignation,
- (d) if found to be involved in any anti social activities,
- (e) if adjudged by any court of law to be a criminal offender or of unsound mind,
- (f) if found guilty by means of anti propaganda of Aims and Objectives of the Society,
- (g) if fails to pay the subscription or contribution within three months from due Date.
- (h) if disregards Rules & Regulations or disobeys the decisions of the Society.

NOTE: The decision of the Governing Body regarding the termination from the membership of the Society, shall be communicated to the member concerned.

6. GENERAL BODY DEFINED:

All the members of the Society will constitute the General Body of the Society.

7. FOUNDER MEMBERS:

Members of First Governing Body/Executive Committee shall be known as Founder Members of the Society.

8. PATRON OF THE SOCIETY:

Governing Body have right to appoint any distinguished/eminent person(s) as the Patron (s) of the Society, from time to time.

9. **GENERAL BODY:**

(a) NOTICE:- Minimum '15' days notice shall be given to the members before the date of General Body Meeting, enclosing

agenda specifying Date, Time, Place and issues to be discussed

- (b) MEETING:- General Body meeting shall be held once in every year regularly within 6 month from the closure of the annual accounts,
- (c) QUORUM:- Quorum of General Body meeting shall be 1/3 (one third) of the total members or 20, (twenty) whichever is minimum.
- (d) URGENT MEETING:- Urgent General Body meeting may be called by 2 days short notice but the quorum for same Urgent General Body Meeting shall be1/3 (one third) of the total members or 20, (twenty) whichever is minimum

10. RIGHTS & PRIVILEGES OF MEMBERS:

Each and every member of the Society:

- (a) Shall be entitled to participate in meetings cultural/educational functions and other lawful gatherings, called/arranged by the Society,
- (b) Have right to collect the Identity Card after depositing the required/prescribed fee (fixed by the Governing Body of the Society from time to time).

11. **DUTIES OF THE MEMBERS:**

Each and every member of the Society shall:

- (a) give the necessary information to Society, pertaining to any matter which is necessary to be known by Society,
- (b) not indulge in activities which are prejudicial to the Aims and Objectives and/or the Rules & Regulations of Society.

GOVERNING BODY:

- (a) STRENGTH:- The strength of Governing Body (including office bearers and executive member) shall not be less than 7 and not more than 21.
- (b) TERM:- The Term of every Governing Body shall be THREE YEARS.
- (c) NOTICE:- Minimum 7 days notice, whether physical or by electronic mode shall be required for Governing Body Meeting.
- (d) QUORUM:- Quorum of every Governing Body Meeting shall be 1/3 (one third) of the total strength or 5 members, whichever

- is lower of the Governing Body (including office bearers and executive member.
- (e) MEETING:- Governing Body Meeting of the Society shall be held as and when the Governing Body of Society may decide from time to time.
- URGENT MEETING:- The Urgent Governing Body may be called by the 24 hour notice but the quorum for the same Urgent Governing Body Meeting shall be 1/3 (one third) of the total strength or 5 members, whichever is lower of the Governing Body of the Society.

13. **FUNCTIONS & POWER OF GENERAL BODY:**

Governing Body shall be responsible for the management and administration of all affairs of the Society, and is also authorized to appoint any office bearer/executive member to look after any particular activity. Governing Body shall have also the following powers:

- (a) To take necessary steps for the implementation of all the programs and policies drawn by the General Body.
- (b) To pass the necessary expenditure to meet the day to day requirements of the Society.
- (c) To take decisions on applications for new membership.
- (d) To prepare plans, projects and programs.
- (e) To manage the affairs of the Society and to keep control over the property of the society and all its assets.
- (f) To invest the funds of the Society not immediately required in such a manner as may be determined by the Governing Body.
- (g) To appoint committee (s) for disposal of any business of the Society or for advise in any matter pertaining to the Society.
- (h) To send representative(s) to any exhibitions or contests and training etc. within or outside India.
- (i) To appoint Returning Officer and his/her powers to complete election process.
- (j) To appoint the Patron(s) of the Society.
- (k) To accept donations, grants, gifts, contributions, subscription and endowments.
- (l) To establish and collect funds and accept donation in cash or in kind and utilize the same for the purpose of Society.
- (m) To receive money, securities, instruments and or any other movable property for and on behalf of Society.
- (n) To enter into agreement for and on behalf of Society.

(o) To take all such other legal steps for smooth/better management of Society.

14. COMPOSITION OF THE GOVERNING BODY:

The composition of the Governing Body (Office Bearers and Executive members) shall be as under:

15. POWERS AND DUTIES OF OFFICE BEARERS:

A. PRESIDENT:

President shall control and supervise the Governing Body and shall have the power to make general direction and management of the affairs relating to the Society.

The President of the Society shall also enjoy the following powers and duties:-

- (a) President shall summon and preside over all the Governing Body and General Body meetings of Society.
- (b) President shall have power to call any emergent meeting by short notice on advice of at least 50% of the members of the Governing Body
- (c) President shall have the power to allow inclusion of any subject/matter in the agenda for the discussion in the course of proceeding/meeting.
- (d) At the time of voting on any matter/subject (except Election), if the total votes of the groups of members happen to be equal in number, the President has the power to cast an extra vote to decide the matter/subject.
- (e) In the course of any proceedings or meetings of the Governing Body or the General Body, the decision of the President shall be considered as final (in case of dispute as to the meaning or interpretation or any Rule)

(f) In case it is necessary to decide any point/matter/issue urgently and there is no time to call the Governing Body Meeting, the President have the powers to decide the point/issue/matter, but he/she shall bring the matter to the notice of the Governing Body as early as it is possible.

B. VICE PRESIDENT:

There shall be one Vice President of the Society to assist the President in his/her work. Vice president shall enjoy all the powers of the President in his/her absence.

C. SECRETARY:

- (a) Secretary shall circulate the notice to the concerned office Bearers and Executive Members/General members
- (b) Secretary will prepare the membership register as well as the proceeding register to record the minutes of the proceedings of the Governing Body Meetings and the General Body Meetings and have them duly signed by the members who attend meetings.
- (c) Secretary will sign all the papers/letters, on behalf of the Society, to conduct its correspondences.
- (d) To appoint/terminate such staff as may be required for effective & efficient management of the affairs of the Society, and fix their remuneration.
- (e) Secretary will ordinarily hold a cash balance not exceeding Rs. 5000/-(or the amount which may be fixed by the Governing Body of the Society from time to time) to meet the emergent needs relating to the Society.
- (f) Secretary will get the accounts of the Society audited by the Qualified Auditor, appointed by the governing Body of the Society.
- (g) Secretary shall file/submit 'Annual List' of Governing Body in the office of Registrar of Societies (Delhi) every year.

D. JOINT SECRETARY:

There shall be one Joint Secretary of the Society to assist the Secretary in his/her work. Joint Secretary shall enjoy all the powers of the Secretary in his/her absence.

E. <u>TREASURER</u>:

- (a) All the funds of Society shall remain under the care and management of Treasurer of the society.
- (b) Treasurer shall maintain the accounts of all money which is received and/or paid by him/her on behalf of the Society.
- (c) Treasurer shall produce all the Account-Books in every Governing Body/General Body Meeting.
- (d) The Treasurer will ordinarily hold a cash balance not exceeding Rs.5000/-(or the amount which may be fixed by the Governing Body of the society from time to time) to meet the emergent needs relating to the society.
- (e) All cash excess of the above amount (or amount fixed by Governing Body) shall be deposited in any Bank/Banks, selected by Governing Body of Society.

F. EXECUTIVE MEMBER

Executive Member is the important part of the Governing Body. Executive Member is supposed to attend all the Governing Body Meeting and also the General Body of Society.

16. ELECTION AND ITS MODE

General Body in its Annual Meeting will elect all the office bearers and Executive MEMBERS OF Governing Body, after every THREE YEARS by secret ballot papers or by show of hands as the Election Officer may decide. The Member (s) who has not submitted his/her subscription shall not be allowed to fight and /or participate in Elections in any way (directly and/or indirectly). Election officer (and his/her powers) will be decided by Governing Body/general Body in its meeting called for this purpose.

17. RE-ADMISSION:

In case, any member of the Society is expelled by the Governing Body on the reason of Non-payment of the subscription, he can be readmitted, provided the member concerned pays all up to Date dues with the permission of the Governing Body.

18. APPEALS:

All the appeals shall be referred to the General Body of the Society. The decision of the General Body shall be final. The decision of the General Body shall be communicated to the member concerned.

19. FILLING UP OF CASUAL VACANCIES:

Any casual vacancy, amongst office bearers & executive members of Governing Body, shall be filled by the resolution passed by the Governing Body. Such appointments(s) shall be confirmed by the General Body in its coming General Body Meeting.

20. SUB-COMMITTEES:

- (a) Governing Body may appoint Sub-committee(s) as and when it considers expedient to assist in the furtherance and achievement of the objectives of Society. Governing Body may at any time dissolve any such committee.
- (b) The Sub-committees shall have such powers as may be delegated to them by the Governing Body.
- (c) Any power delegated to such committees may be withdrawn by Governing Body at any time (without any notice).

21. BRANCHES:

Governing Body, in its meeting, shall form the Branches and/or the Sub-committees (all over India and Abroad) to attain the Aims and Objectives of the Society.

22. SOURCES OF INCOME AND UTILIZATION OF FUNDS:

All the income of Society (received from all sources) shall be utilized only for the promotion/up-liftment of Aims and Objectives. Sources of Income of the Society are as under:

- (a) Admission Fee and Subscription from the members of the Society,
- (b) Donations and Special Contribution...and
- (c) Funds generated by Exhibitions, functions, Seminars and other Cultural programs arranged by the Society.

23. ADVISORY BOARD:

Governing Body is authorized to appoint/nominate, any time, the Advisory Board to solve any matter/issue. The Governing Body of the Society can nominate any Office Bearer/Executive Member as the CHAIRMAN of this kind of Advisory Board.

24. FINANCIAL YEAR:

Except first financial year, which will start from the date of registration and will end on 31st March of succeeding year, all the Financial year shall be from 1st. Day of April to 31st. March of succeeding year.

25 MANAGEMENT OF FUNDS & ACCOUNTS OPERATION:

Entire amount shall be kept in any Bank(s), where the Governing Body/General Body may decide from time to time. Bank accounts shall be operated by Joint Signatures of any two officers from PRESIDENT, SECRETARY and GENERAL SECRETARY.

26. AUDIT OF ACCOUNTS:

Accounts of Society shall be audited by qualified auditor (C.A.) every year.

27. ANNUAL LIST OF GOVERNING BODY:

Once in every year a list of the Office-Bearers and the Executive Members (of the Governing Body) shall be filed in the office of the Registrar of Society (Delhi), as it is required under Sec. 4 of "SOCIETIES REGISTRATION ACT, OF 1860"; as applicable to National Capital Territory of Delhi.

28. **DISSOLUTION:**

(a) If the Society needs to be dissolved, it shall be dissolved as per provisions laid down under Sec. 13 & 14 of "SOCIETIES REGISTRATION ACT, 1860, as applicable to National Capital Territory of Delhi.

(b) If upon the winding up or dissolution of the society there remains after satisfaction of all its debts and liabilities any property whatsoever, the same shall not be paid to or distributed among the members of society, but shall be given or transferred

to some other society, having similar objectives like this society, to be determined by the members of the society at or before the time of dissolution.

29. **SUITS BY AND AGAINST SOCIETIES:**

Society may sue and/or be sued in the name of President and/or Secretary as per provisions laid down under Sec. 6 of the "SOCIETIES" REGISTRATION ACT, 1860"; as applicable to National Capital Territory of Delhi.

Provided that is shall be competent for any person having a claim or demand against the society, to sue the Society as a judicial person and the President/Secretary or any Member nominated by the Governing Body shall defend the Society on its behalf,

A registered society is not a corporation but is like a Joint Stock Company or a Club.

30. **AMENDMENT:**

Any amendment in the Memorandum of Association, Rules and Regulations will be carried out in accordance with Section 12 & 12-A of the "SOCIETIES REGISTRATION ACT, 1860"; as applicable to National Capital Territory of Delhi.

31. **APPLICATION OF THE ACT:**

All the provisions under all the Section of "SOCIETIES REGISTRATION ACT, 1860"; as applicable to National Capital Territory of Delhi, shall be applicable to this Society.
