Post Agenda Discussion and Remarks by Members

After the formal agenda items were concluded, Mr. Ramakant Pathak expressed his gratitude to the members for their participation and invited Mr. Gurudeo Sinha to share his thoughts. Mr. Sinha, in a humble gesture, requested Mr. Sunil to address the gathering first. Mr. Sunil, a founding member of the association, expressed his sincere thanks and stated:

"This is Sunil. I feel privileged to be associated with this welfare society since its inception. Our collective journey to build and shape Mezzaria is ongoing and filled with challenges, yet equally inspiring."

He also brought to the attention of the members the following key concerns that still remain unresolved:

- One-third of the towers are yet to receive Occupancy Certificate (OC) and Completion Certificate (CC).
- Approximately 10% of homebuyers are still awaiting possession of their units.
- Almost 100% of residents have expressed dissatisfaction regarding the current state of services and amenities.

"Despite more than five years having passed since the first residents moved in, we are yet to achieve the status of a fully functional society," he added.

Mr. Sunil encouraged all members to refer to detailed updates and reports available on the association's official website and stressed the importance of transparent communication among residents.

Thereafter, Mr. Gurudeo Sinha addressed the members and conveyed:

"It is indeed an honour to address the General Body today. The true strength of our society lies in our unity and the unwavering support we extend to one another."

He further acknowledged the valuable contribution of key individuals:

- Ms. Meenakshi and Mr. Jhamb for their selfless dedication and consistent efforts.
- Mr. Ramakant Pathak for his compliance-related support and administrative coordination.

He added:

"Although we have not initiated any legal proceedings so far, we remain committed to



safeguarding the collective interest of all members. As we move forward, let us work in close coordination and mutual respect."

Mr. Gurudeo Sinha also thanked Mr. Sunil for his leadership and long-term vision and took the opportunity to welcome the newly added members to the association, namely:

He expressed appreciation to all participating members for making the AGM meaningful and successful through their engagement.
